Nowadays, studies in cognitive metaphors in political discourse are more than widely-spread. Only in the XXIst century, the quantity of such researches runs to more than 300 throughout the world [6]. Yet investigators are inclined to accentuate the factor of individual body experience, and sometimes socio-political experience, while the subject of cultural specific has hardly been modeled by researchers. For this reason, the current study identifies studies on metaphorical framing at the level of words as well as concepts. Applying both approaches will provide a comprehensive overview of metaphorical-framing effects in political discourse by showing whether and how metaphorical frames influence political persuasion compared to non-metaphorical frames through words versus concepts. The metaphorical frames in both studies were thus based on the conceptual metaphor of politics is war (Lakoff & Johnson, 1980). Studies on metaphorical-words framing are characterized by a focus in the method sections on the use of linguistic metaphors in the experimental conditions. Many of the metaphors used in politics draw heavily and systematically on the languages of sports and warfare. He argues further that, "Sports and warfare metaphors are not just rhetorical devices for talking about politics, for they exemplify how people ordinarily conceive of politics. "For political scientists, the comparative study of metaphors provides a new and hitherto largely unexplored way of understanding the similarities and differences in the way political systems are conceptualised" (Ringmar, 2008, p. 58). However, one of the main reasons I wrote the book was to help non-native English speakers make sense of these thousands of metaphors used in such high frequency in normal political discourse.
