Si Through a series of major investment funds and development aid projects, Australia and China are trying to outbid each other to create networks of power and influence in poorer Pacific nations.Â In November 2018, Australia set up an infrastructure bank worth 2 billion Australian dollars for projects in the Pacific region and said it will spend 1 billion more promoting exports and supporting Australian businesses in the Pacific. Chinese President Xi Jinping in Port Moresby, Papua New Guinea, on November 16. China has taken the lead in providing development aid in PNG and throughout the region. This should be a wakeup call to Australia and US allies in the region.
